


Waste Management Bylaw #A-764

Please be advised that according to Bylaw #A-764 all residents and businesses are required to place their bagged waste or bagged garbage in a proper garbage container or receptacle. A garbage container or receptacle under the bylaw means a metal, wood or plastic garbage container or receptacle with a secure lid to prevent the invasion of birds or animals. Should this bylaw not be adhered to you may be subject to a \$100.00 fine for the first offence and a \$200.00 fine for the second and subsequent offences.

Please ensure that when you place your garbage ready for pick-up that it is placed in a secure garbage container so that animals and birds cannot rip the bags open and drag the garbage everywhere.

The Village office has received complaints of such happenings of late.
