



BY-LAW No. A804

**A BY-LAW OF THE VILLAGE OF CONSORT IN THE PROVINCE OF ALBERTA
TO AUTHORIZE THE COUNCIL TO ESTABLISH RATES CHARGED FOR VARIOUS
MUNICIPAL SERVICES**

WHEREAS the Municipal Government Act, being Chapter M-26, R.S.A., 2000, as amended, authorizes the Council to pass, repeal or amend any bylaw;

NOW THEREFORE, under the authority of the Municipal Government Act RSA 2000, Chapter M-26, the Council of the Village of Consort duly assembled enacts as follows:

1. This Bylaw may be cited as the **"Master Rates Bylaw"**.
2. That the Master Rates Bylaw No. A-804 with "Schedule A" attached is established as the Master Rates Bylaw for municipal services provided by the Village of Consort.
3. That GST will be added unless otherwise noted. GST does not apply to fines.
4. Utility billings shall be mailed on the 1st of every month for usage of the previous month.
5. No utility account shall be set up for an occupant of a parcel of land who is not the owner for the use of the water supply and distribution system, sanitary sewer collection and disposal system, or for the provision of waste disposal services.
6. The owner of a property may request a copy of the invoice be mailed to the tenant; however the property owner will receive the original invoice.
7. All public utilities accounts are due on the 15th of every month. Penalties on all overdue public utility accounts shall be 2%. All overdue accounts not paid by December 31st of any year shall be transferred to taxes on January 1st of the following year and collected by the same procedures as taxes.
8. That should any rates mentioned here that still appear in older bylaws not yet revised that the rates mentioned in this bylaw shall be in full force and effect and supersede previous rates.
9. That Master Rates Bylaw No., A-804 comes into full force and effect on January 1st, 2014.
10. That Bylaw A7883 now is repealed.

SEVERABILITY

11. If any portion of this bylaw is declared invalid by a court of competent jurisdiction, then the invalid portion must be severed and the remainder of the bylaw is deemed valid.

Read a third and final time this 9 day of December, 2013.
